Dear Friend:

Survivors of sexual assault rely on medical professionals to treat their physical wounds, help them seek justice and provide support for the severe emotional trauma as they embark on a challenging recovery journey.

Sexual Assault Nurse Examiners are crucial in ensuring that sexual assault patients receive more compassionate care. Specially-trained nurses can reduce re-traumatization of patients and improve the quality of forensic evidence collection, which may increase prosecution rates of offenders. No matter what role you play in this critical process, your invaluable work places you on the frontline in the fight against sex crimes and makes you one of the most important people in victims' lives.

I would like to invite you to attend the **Adult/Adolescent Sexual Assault Nurse Examiner (SANE) Didactic Training** on **February 25-27, 2025**, from 8:00 a.m. – 5:30 p.m. at Sarah Bush Lincoln Hospital in Mattoon. Instructions regarding the pre-coursework will be released to participants on January 23, 2025, and the online coursework must be completed by Thursday, February 20, 2025.

The **Adult/Adolescent Sexual Assault Nurse Examiner (SANE) Didactic Training** is an important 40-hour training designed to improve the response to sexual assault patients in Illinois. The training is comprised of a combination of pre-coursework and live training. Participants can complete the pre-coursework at their convenience; however, the assignments must be completed by the due date provided.

This training is for registered nurses, advanced practice providers and physicians who will be providing medical forensic services to sexual assault patients in the Emergency Department. Applicants must have a license in good standing, acknowledge the requirements of the training including submitting a current resume, complete the pre-coursework prior to the date listed above, have an established mentor (must be an AA SAFE, SANE-A, or AA SANE practicing in Illinois) who has received specialized training in the care of sexual assault patients, work in a treatment facility's emergency department or have developed a clinical plan with an emergency department and be available for the in-person training. Individuals who have previously completed didactic training are invited to re-attend as space allows.
